The Facebook photo competition will run in 2 stages. The first stage will be the submission period where people send their photos to the Attendant Care Autism Services page on Facebook which will run from July 29th, 2019 at approximately 9:00 am est. to August 9th, 2019 at 11:59 pm est. The second stage will be the public voting period, and run from Tuesday August 13th, 2019 at approximately 9:00 am est. to August 18th, 2019 at 11:59 pm est. Winner will be announced on August 19th, 2019 via Facebook message. The winner's name and their photo will be posted on all of the social media platforms operated by Attendant Care Companies of Michigan (Facebook, Twitter, and Instagram) as well as published on the website news and events page at www.ACCAutism.com.

The competition is all about summer fun! We had a cold hard winter and it is finally warm enough to enjoy the great outdoors. We are looking for photos of people wearing their favorite sunglasses, or the Attendant Care Autism Services sunglasses that were obtained at one of our public events, and enjoying the summer!

One winner will receive a \$50 Gift Card to Detroit Wing Company.

To enter, Facebook users must submit a photo of a person wearing sunglasses and enjoying a summer activity during the submission period. To be eligible to win, the user must also be following Attendant Care Autism Services' (@ACCAutism) Facebook page. A valid submission can come through a response to the **ORIGINAL** post announcing the competition made by Attendant Care Autism Services, a new post tagging Attendant Care Autism Services' Facebook page, a message via Facebook Messenger to Attendant Care Autism Services, or by a public post on the Attendant Care Autism Services Facebook page.

Once the submission period has closed, staff at Attendant Care Autism Services will determine the top 5 photos based on an internal employee vote. The top 5 photos will then be posted to Facebook in a new post on August 13th, 2019 that will then start the public voting period. During this period Facebook users will be asked to vote for their favorite picture by "Liking" the picture of their choice. "Liking" is being defined as any positive action that can be done through the "Like" button (Thumbs up, Heart, Laughing, or Wow emojis) on Facebook. Any negative action that can be done through the "Like" button (angry face, crying face) on Facebook will not count negatively toward the picture and will not be tabulated in any means. Once the public voting period has ended, the votes will be tabulated and the winner will be contacted and announced.

In the case of a tie, winner will be determined by a random coin flip by Attendant Care Companies staff. Video of coin flip will be sent to the winner and the loser of the coin flip upon their request.

Summer activity is defined as any activity that a person is doing during the summer. Examples can be: family cookout, watersports, yard activities, relaxing activities, etc.

Anything that is deemed to be lewd or illegal will be automatically disqualified and subject to possible reporting to proper authorities.
